Summary Report of the 8th Council Meeting (13-06-2016) & 9th Council Meeting (18-08-2016) of KLSCCCI for Year 2015-2018

Discuss and Approve Constitutional Amendments

After due deliberation, the Council Meeting unanimously approved the proposed amendment for onwards submission to KLSCCCI's AGM 2016. The related articles are as follows:

- Article 11(2) : The Council may appoint not more than four (4) members from among members of the Chamber, including Ordinary Associate Members, Associate Life Members, or Associate Eminent Members to be additional Council members PROVIDED THAT the Council member so appointed shall be a Malaysian citizen of Chinese origin.
- Article 8 : Time of Payment The annual subscription shall be paid by the Eminent Members, Associate Eminent Members, Ordinary Members and Associate Ordinary Members on or before the 31st day of March each year.

Besides, regarding the suggestion to include the amendment of increasing the number of Vice Presidents during the last Council Meeting, the effective date will be next term.

General Affairs Committee

Matters Pertaining to Change of Representative of Council Member Representing Trade Association

The Chamber received a letter from The Selangor & Kuala Lumpur Foundry & Engineering Industries Association on 27th June 2016, confirming the change of its authorised representative to KLSCCCI, from Mr. Fan Hai (President) to Mr. Au Kah Khiong (Director) and as Council Member of KLSCCCI. At the same time, the previous post of Committee Member of the SMEs and HRD Committee held by Mr. Fan Hai will also be taken over by its new representative, Mr. Au Kah Khiong. Mr. Au Kah Khiong is presently a Committee Member of the Industry Committee.

Labour Policies

Secretariat submitted a brief information of Minimum Wages Order 2016 for meeting's perusal. The Committee Chairman indicated that Government has been promoting industrial automation especially for industries which are heavily reliant on foreign labour. Therefore, the Minimum Wages Order is expected to reduce their dependency on labour.

The Committee Chairman also informed that the SOCSO ceiling of wage for contribution payment has been raised from RM3,000 per month to RM4,000 per month effective from 1st June 2016.

The Management Committee has unanimously approved to relax the restriction for applicants obtaining PTPTN Loan, and suggested to amend the related term of Qualifications in the Guidelines.
